It all started a few months ago. I was registering folks for the PPTU tying classes, and noted that we charge "members" of PPTU one fee and "non members" a higher one. I was speaking with Lance Flood, our Membership Chair, and I asked him a simple question -- "Lance," I asked, "I have a guy who is a member of the Seneca Valley Chapter of TU, but he has already paid a PPTU membership assessment so he can get our newsletter. How much should I charge him?"

That simple question started a snowball reaction on the PPTU Board of Directors which resulted in many, many man hours invested in bringing our chapter and its policies into compliance with our current bylaws and the bylaws of National TU.

I'm going to briefly outline the changes the PPTU Board has adopted, but I ask you to understand that most of the changes are superficial and merely change the way we talk about and think about procedures already in place. This is a complex issue, and I hope you will read this entire article in order to grasp the complete picture. Stick with me, and follow the outline below. We will be discussing the upcoming changes at chapter meetings, too, so any questions you may have can be answered there.

What follows is the sum of what has been changed or re-defined in order to bring PPTU into compliance with all relative bylaws: Who is a member of PPTU? -- Our bylaws, written to comply with the National TU requirements

we had to follow in order to qualify for our National TU charter say: any person who has been assigned to PPTU by National TU is a member of PPTU. What is the PPTU Newsletter? -- Since our bylaws require us to send

a newsletter to each and every PPTU member, not just to assessment paying members, PPTU now has a new annual newsletter which is currently being mailed as a supplement in one issue of *The Conservationist* to all members listed in our data base. It will contain information about our meetings, education programs, and our conservation activities. Whether or not they have paid an assessment, the new, annual newsletter is being sent to all PPTU members. In addition, it will also be published, annually, on our web site. *The Conservationist* will continue to be published as before, but will never again be referred to as our newsletter. More on this below -- stay with me.

How about the "Membership Assessment?" -- The fifteen dollar Annual PPTU Membership Assessment has been renamed. Since we never really had authority to levy an assessment on anyone, the assessment has been renamed, the **Annual Supporting Contribution**.

What is the Annual Supporting Contribution? -- The Annual Supporting Contribution is a donation, currently in the minimum amount of fifteen dollars, made to PPTU by anyone who wishes to support our chapter's activities.

Why do we need to have an Annual Supporting Contribution? -- When a chapter signs up a new member at a show or through a membership drive, the first year National TU gives that local chapter a substantial rebate from the dues collected from the new member. Thereafter, each succeeding year that chapter only receives a very small rebate from National TU for each member retained on that chapter's rolls. It usually amounts to about a dollar and a half or less.

When you consider our meeting room rental fees, guest speaker fees, float stocking expenses, contributions to outside educational camps for kids, Trout in the Classroom expenses, donations for tree plantings, all the other conservation activities we

sponsor, the educational programs we foster, along with the cost of publishing and mailing *The Conservationist* and now the new *Annual Newsletter*, the National TU rebates do not come close to meeting our chapter's financial needs. Therefore, we have fundraisers, and we are now asking each and every one of you to become a member who fully participates, and we ask you to show your support by making an Annual Supporting Contribution of fifteen dollars to the chapter so we can continue the good work our loyal army of volunteers makes possible with the donation of thousands of man hours of labor they provide for the chapter.

The good news is you will no longer be assessed fifteen dollars in order to have the privilege of being a PPTU member. The old "Membership Assessment" is no more. If National TU assigned you to PPTU, whether or not you choose to fully support us with a fifteen dollar, Annual Supporting Contribution, you are still a PPTU member but, please -- make that contribution to keep us effective in accomplishing our mission.

There will be additional incentives for you to make an Annual Supporting Contribution. More will be discussed and announced later, but for now members who make an Annual Supporting Contribution will receive discounts on many of the activities and sale items for which the chapter charges fees such as, the PPTU tying classes, shirts, hats, books and more. Annual Supporting Contributions may be given at meetings, by use of a form you can print and mail from our web site, or by using the form included in this publication.

And *The Conservationist*? -- Those making Annual Supporting Contributions will also receive a subscription to our publication, *The Conservationist*. Using the form provided here, the members who choose to make the fifteen dollar Annual Supporting Contribution can elect to receive a hard copy of

*The Conservationist* by mail, or they can elect to join the new list server Robert Simpson has organized for the sole purpose of making *The Conservationist* available to them on line. In addition, each time *The Conservationist* is published, the first page will be posted on the PPTU web site, but only the first page. Thereafter, when the next issue of *The Conservationist* is published, the entire previous issue will be placed in the archive on the PPTU web site. Importantly, from a membership recruitment and public awareness viewpoint, complimentary hard copy issues of *The Conservationist* will continue to be sent to many fly shops, conservation organizations, newspapers and others who often help us out when we need a voice.

I sincerely hope the above hasn't confused anyone. After you have had a moment to digest what I just said, you will see that not much has really changed. Yes, now we have an annual newsletter that is sent to each of our newly re-defined members. Yes, you will still be able to read that great publication from your chapter, *The Conservationist*. Yes, we are still asking you for \$15 a year to support us, however, at least we are no longer assessing you for it, but we really hope you will make that donation a priority since we depend so heavily on it to function the way we do.

I personally want to thank those brave and persistent souls who served on the membership committee, Robert Simpson, Nick Weber, Bob Dietz, and Jay Sheppard, for all of the hours they spent hammering out the semantics of these changes for us. I would like to point out that only through hours of hard work, discussion, and compromise they presented the PPTU Board with a workable plan to bring us into complete compliance with all of our relative bylaws, and they still managed to keep the wonderful character of our chapter intact. Thanks also to our Board of Directors for the hours of discussion that went into approving these changes.

## The PPTU List Server

The chapter operates a listserver that all members are welcome to join. Over 150 members currently make use of this opportunity to post email messages to the group and receive email messages posted by others. The information you find here is great stuff that you can't find anywhere else. The Listserver topics cover all aspects of trout fishing and will improve your knowledge of the sport. So don't be left out.

To subscribe, send an email from the email account you want added to the listserver, to

[ppctu-subscribe@yahoogroups.com](mailto:ppctu-subscribe@yahoogroups.com). Within a few days and often within a few hours, you will receive an email confirming your membership on the listserver.

Once on the list, you can post messages to the entire group by addressing your email to

[ppctu@yahoogroups.com](mailto:ppctu@yahoogroups.com). There are several options as to how messages from the listserver will come to you. The default is for the listserver to send you each message posted to the group as it arrives. A second option is to receive a daily digest, a single email containing all the messages posted during the last day.

A third option is no email deliver, using instead an onlive archive of messages. However, attachments that go out with messages via the other options are NOT kept in the archive, so sometimes you miss out some things with this option. Lately, listserver message traffic has run between 100 and 300 messages per month. If you would like to use one of these other options and aren't familiar with how to change this setting, or if you encounter any other problems with using the listserver, send an email to [ppctu-owner@yahoogroups.com](mailto:ppctu-owner@yahoogroups.com) and we'll try to help.
